(sucrose, yeast, and trimethylamine), (Sterling International, Inc.) for control of various flies by use of attractants and traps for outdoor and indoor areas. **(WH)**

SPLAT CLM™ ((Z,Z,E)-7,11,13-Hexadecatrienal), (ISCA Technologies Inc., EPA Reg. No. 80286-15) for mating disruption of the citrus leafminer, (*Phyllocnistis citrella*), on all crops and non-crop areas (including residential areas) where the citrus leafminer is detected. **(GT)**

TENET WP, (*Trichoderma asperellum* ICC 012) and (*Trichoderma gamsii* ICC 080), (Isagro SpA, EPA Reg. No. 80289-9) for use on food crops, ornamental plants, ornamental trees, and turf grass. **(RM)**

SNU REGISTRATIONS

BELAY 50 WDG INSECTICIDE, (clothianidin), (Valent USA Corporation, EPA Reg. No. 59639-152) for control of sucking and chewing insects infesting fruiting vegetables (including cucurbits) and leafy vegetables (including brassica vegetables). **(WH)**

**REGISTRATION ACTIONS ON PENDING ITEMS**

NAI REGISTRATIONS

RESCUE JAPANESE & ORIENTAL BEETLE TRAP, (oriental beetle pheromone and nuranone [Japanese beetle pheromone]), (Sterling International, Inc., EPA Reg. No. 84565-1-49407) for control of Oriental and Japanese Beetles on flowers, fruits, vegetables and lawns by use of trap. This brand was registered effective **April 1, 2010**. **(WH)**

SLN/SNU REGISTRATION

MUSTANG® INSECTICIDE (zeta-cypermethrin), (FMC Corporation, EPA Reg. No. 279-3126) for low volume aerial application to Florida citrus for control of Asian citrus psyllids. **EPA SLN NO. FL-100002** was issued effective **March 23, 2010** after receipt of a final revised label and compilation of documentation to be submitted to EPA. **(GT)**

**PENDING BUSINESS**

CADET HERBICIDE (fluthiacet-methyl), **(NAI)** (FMC Agricultural Products, EPA Reg. No. 279-3338) for control of velvetleaf and other broadleaf weeds in soybeans, field corn, sweet corn for processing only, and popcorn. Awaiting the additional information requested by the Committee. **(AS)**

FOLICUR 3.6 FOLIAR FUNGICIDE, (tebuconazole), **(SNU)** (Bayer CropScience, EPA Reg. No. 264-752) for use on food crops such as beans, corn, cucurbits, and leafy brassica greens. Awaiting information regarding effects on bees. **(RM)**

**PENDING BUSINESS (CONT'D)**

IMPACT HERBICIDE, (topramezone), **(NAI)** (AMVAC Chemical Corporation, EPA Reg. No. 5481-524) for postemergence weed control in field corn (grown for grain, silage or seed) popcorn and sweet corn. Awaiting a response from the registrant on label discrepancies. **(CC)**

MERIT 2F INSECTICIDE, (imidacloprid), **(SLN)** (Bayer CropScience LP, EPA Reg. No. 432-1312) to control Asian Citrus Psyllid in citrus. DACS received the December 1, 2008 IFAS review, which noted the lack of site specific Florida efficacy data for the product by reviewers. The review was provided to the registrant, and they are in the process of compiling the lacking efficacy data for re-submission to IFAS. The label clarification was resolved at an interim meeting with FFWCC. **(WH)**

OF COURSE, (rhamnolipid biosurfactant), **(NAI)** (Jeneil Biosurfactant Co., EPA Reg. No. 72431-1) to control fungi on turf grass. Awaiting a response from the registrant to the Committee members' labeling questions. **(RM)**

PORTAL® MITICIDE/INSECTICIDE (fenpyroximate), **(SNU)** (Nichino America, Inc., EPA Reg. No. 71711-19) for aerial application on citrus and ground application on fruiting vegetables, melons and 'low-growing' berries. Awaiting clarification of label statements on the supplemental labeling for aerial application to citrus. **(GT)**

REFLEX HERBICIDE (fomesafen), **(NAI)** (Syngenta Crop Protection, Inc., EPA Reg. No. 100-993) for control of broadleaf weed grasses and sedges in cotton, dry beans, snap beans and soybeans. Awaiting a response from the registrant to address the review comments of the Committee. **(AS)**
